Terms & Conditions

1. Bidder may visit the sites for assessing the volume of the work involved and submit the quote accordingly. The bidder has to do the scaffolding works for protection and remove the scrap materials as buyback after work completion.
2. The works shall be completed within 7 days of confirmed work order. Late completion of works will be penalized at 1% per week.
3. A completion certificate has to be obtained from the concerned officer in charge after the work completion.
4. 100% payment will be made by KSITM within 30 days on submission of invoices.
5. An amount equivalent to 5% of the work order value shall be submitted to KSITM within 7 days of issuance of work order, which will be returned after the successful work completion.
6. The bidder shall remove all the scrap materials from the site locations immediately on completion of works and buyback payment will be deducted from the payments to the bidder.
7. KSITM will seek clarification from the bidder for the evaluation of bids and the decision taken by KSITM will be final.
8. Bidder shall be solely responsible for any damages / consequences arising due to mishandling. Necessary safety measures should be ensured by the bidder while carrying out the works.
9. The financial bid to be submitted as per the format given above.
10. Any quotation received after the time fixed on the due date is liable to be rejected. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
