Sealed tenders are invited from the companies for doing the tower dismantling works across the State for Kerala State Wide Area Network (KSWAN) project on a rate contract basis for a period of one year. Interested firms may submit the bid to Director, Kerala State IT Mission on or before 10/10/2018, 5 PM. in a sealed cover in the format as per Annexure-3.

#### **Background**

Kerala State Wide Area Network (KSWAN) is functioning as the network backbone for connecting the various Govt. offices to the State Data Centre located at Thiruvananthapuram. As part of KSWAN, 166 Base Towers (GBT with 39 mts) and 1200 Remote Wireless towers (Guy mast Towers) were installed at the Govt. offices across the State for providing connectivity through wireless backhaul. Based on requests from the Govt. departments for the dismantling of tower due to building construction / renovation activities, KSITM is floating this tender for finding an agency to carry out these works.

#### **Scope of Work**

- 1. Bidder shall carry out the dismantling of the Ground based / Guy mast tower safely following all safety measures at the site locations. Bidder will be solely responsible for any damages / consequences arising due to mishandling of the dismantling works.
- 2. The works shall be carried out within 15 days from the date of issue of work order / intimation email from KSITM. If the number of sites given is more than five at a time, then the period will be 30 days.
- 3. The materials dismantled shall be kept under the concerned Office and a completion certificate has to be obtained from the concerned officer in charge after the work completion.

#### **Experience of the Bidder**

1. The bidder should have prior experience in doing the tower shifting / dismantling works in Kerala within the last 7 years. The supporting documents in this regard shall be submitted to KSITM by the Bidder along with the bid.

#### **Payment terms**

- 1. Payment will be made by KSITM within 30 days on submission of invoices and dismantling certificate.
- 2. A performance bank guarantee amounting 10% work order amount has to be submitted to KSITM which is valid for 6 months otherwise 10% amount will be deducted from the payment to the bidder which will be released after 6 months of work completion.

#### **Other Terms & condition**

- 1. Bidder can visit the site locations on sample basis to assess the volume of work involved to any of locations mentioned in the annexure.
- 2. Late completion of works will attract a penalty amounting 1% for the delayed sites for each week of delay.
- 3. Bidder has to carry out the works across the State at the same rates quoted during the period of contract. The site list for which the dismantling works to be carried out will be provided by KSITM based on the requests from the user departments.
- 4. The quantities mentioned are approximate which may varies based on the requirement arises during the period of contract.
- 5. The period of contract will be valid for one year from the date of submission of bid.
- 6. Kerala State IT Mission will not responsible for any damages / consequences caused during the dismantling works to any person / commodity.
- 7. Service tax will be paid by KSITM on actual applicable at the time of invoicing.
- 8. KSITM reserves the right to cancel this contract at any time with or without assigning any reasons.

- 9. <u>Earnest Money Deposit (EMD) shall be submitted in the form of DD to Director, Kerala State IT Mission at the time of submission of bid. The bids will be rejected if the EMD is not submitted.</u>
- 10. KSITM will seek clarification from the bidder for the evaluation of bids and the decision taken by KSITM will be final.
