ORDER

Government is on receipt of several requests from various Departments for availing broad band connections of Bharat Sanchar Nigam Limited (BSNL) for official use in their Line offices. Discussions have been made with BSNL for offering FTTH Plans in discounted rates for the use of Government Departments. Accordingly, BSNL has offered two plans for Government offices as detailed below:

2. Government have examined the matter in detail and sanction is accorded to Govt Departments to opt any one of the above FTTH plans as per their actual requirement subject to the condition that the Department / Office should sign a Service Level Agreement with the BSNL for the purpose. The above mentioned tariffs are excluding taxes.

3. The Director, Kerala State IT Mission shall prepare a draft Service Level Agreement in consultation with BSNL for the above purpose and upload the same in the

website of Kerala State IT Mission for the use of Departments / Offices.

4. The Departments need not consult Electronics & IT Department to opt any one of the above plans, in future.

5. Concurrence of Electronics & IT Department is necessary for opting higher plan other than the above two plans.
